

## Why is community-engaged governance important?

- Community-engaged governance is an important principle to ensure research aligns with community values, needs and goals, promoting the concept of 'nothing about us, without us'.
- Valuing and ensuring meaningful involvement through community-engaged governance in research can also build the capacity of communities to lead and become involved in research activities by developing their skills and their power to direct research in their community.
- Community involvement in research is of great importance because when research is co-produced with community members, research teams remain accountable to the goals and values of the community they are conducting research with, ensuring effective, practical and relevant research outcomes are more likely.<sup>36,37</sup>

## How has the Journey to Home Project integrated project governance models?

- The Journey to Home Project has incorporated a project governance model that involves community/peer advisors, community agencies working with CaLD health and social services, those working in homelessness and housing, and mental health, government stakeholders, and researchers.
- We envisioned that incorporating the perspectives of both community/peer and organisational representatives would improve our understanding of context and ensure early consideration of key issues to develop outcomes in a way that is relevant and appropriate for end user organisations.

The RSG is made up of PAT and PIT members and representatives from key agencies. Agencies provide strategic advice to the PAT and PIT, ensure accountability for agreed outcomes. These agencies assist to establish relationships with community, inform the development of the intervention, assist to make sense of trends and themes from data and development of policy and practice ready recommendations. Furthermore, the RSG assists with the dissemination of findings and promote the project to other stakeholders.

### **Community & Peer Advisory Group (CaPAG)**

The CaPAG involves five community and peer advisors, the project officer, CIA, two other members of the PAT and a lived experience consultant to provide training and support to the CaPAG. The purpose of the CaPAG is to ensure research is conducted ‘with’ end users, appropriate to the community need and facilitates community ownership.
